Expression of Interest is invited by the County Government of Laikipia from reputed Companies with required experience to construct and manage zipline operations at Thompson's Falls, Nyahururu. The project will be on **lease basis**. The Fall is a 74 metres (243 ft) waterfall on the Ewaso Ngiro river, a few kilometres from Lake Ol Bolossat, which drains from the Aberdare Ranges. It is situated 2 kilometres from the town of Nyahururu, at 2,360 metres (7,740 ft) elevation. The fall is a major tourist attraction site which attracts many tourists both local and international.

Details of the scheme and eligibility etc. and the prescribed application format are given in the TOR document, which will be available at the office of the Head of Supply Chain, County Government of Laikipia or at the county website (www.laikipia.go.ke).

The bid containing **Financial Proposal** in the prescribed format **sealed in an envelope**, completed in all respects, shall be submitted to the Head of Supply Chain, County Government of Laikipia, clearly marked on the envelope "**EXPRESSION OF INTEREST FOR CONSTRUCTION AND MANAGEMENT OF ZIPLINE OPERATIONS AT THOMPSON'S FALLS, LAIKIPIA COUNTY**" by hand/ post/courier/ on or before and addressed to: -
